TIANJIN LOWERS COVID-19 EMERGENCY RESPONSE TO THIRD LEVEL



Tianjin has lowered its emergency response to the novel coronavirus epidemic from the second level to the third level starting from June 6th, 2020. The third emergency response level is the second-lowest. Prevention and control measures will be adjusted accordingly. Under the third level, residential areas will continue with code inspections and information registration, but body temperature checks won't be required. Public spaces such as libraries, museums, parks and scenic spots are opening, with visitors limited to 50% of the normal number.

THREE NEW COMPREHENSIVE BONDED ZONES APPROVED IN TIANJIN



Tianjin Municipality has received approval to set up three new comprehensive bonded areas in its Binhai New Area, according to local authorities. Comprehensive bonded areas are special commercial zones that enjoy favourable taxation policies and are managed by customs officials. The State Council approved the upgrade of the Tianjin Export Processing Zone, Tianjin Dongjiang Free Trade Port Zone, and Tianjin Bonded Logistics Park to

comprehensive bonded areas. Now, Tianjin has four comprehensive bonded areas covering 13.41 square km. As important platforms for an open economy, comprehensive bonded areas are significant to developing foreign trade, attracting foreign investment, and promoting industrial transformation and upgrade, said Liu Xintong, deputy director of Tianjin Customs, at a news briefing.

THE FOURTH WORLD INTELLIGENCE CONGRESS HELD ONLINE IN TIANJIN



Cutting-edge technologies such as artificial intelligence, augmented reality and virtual reality were leveraged to create a new platform to showcase China's technological prowess at the Fourth World Intelligence Congress, an online event held on 23-24 June in Tianjin. Jin Xiangjun, vice-mayor of Tianjin, said digital and intelligent technologies played a vital role in combating the novel coronavirus outbreak, and in the post-epidemic era, more Al-powered application scenarios and solutions that inject new impetus into economy and society are needed.

TIANJIN: MAN CLEANING FROZEN SEAFOOD AT HOTEL CATCHES COVID-19 VIRUS



Tianjin reported one new confirmed COVID-19 case—a 22-year-old man working at Tianjin's Conrad hotel. The patient has been washing dishes in the

hotel since 30 May, occasionally cleaning frozen seafood. Tianiin Centre for Disease Control and Prevention (Tianjin CDC) said that the man has no history of traveling in the 14 days prior to the onset of his illness, no contact history with confirmed cases or suspected cases. The patient had a fever on the Tuesday and went to three hospitals and received nucleic acid testing. He tested positive on the Wednesday morning, with light symptoms. Tianjin also suspended some cross-regional coach services to Beijing on Tuesday to avoid the spread of infection. The municipality requires citizens who have been to medium and high risk areas in Beijing in the past 30 days to report to their communities, and those who conceal their itineraries and cause the spread of the disease will be held accountable. local news reported. According to the report, people who travel from Beijing are allowed to enter Tianjin as long as their health QR code appears green. Those with red codes should be quarantined for two weeks in a designated spot, and those with yellow codes should quarantine at home for two weeks.

TIANJIN BASED CANSINO'S RECOMBINANT COVID-19 VACCINE APPROVED AS SPECIAL MILITARY DRUG



Chinese biopharmaceutical firm CanSino Biologics Inc announced on Monday that a recombinant novel coronavirus vaccine (Ad5-nCoV) the company developed with a military research team has received special one-year military drug approval. The approval for the military use of Ad5-nCoV was granted by the Health Bureau of the Logistics Support

Department of the Central Military Commission on June 25, for one year. Ad5-nCoV is currently limited to military use and cannot be expanded to a broader vaccination range without the approval of the Logistics Support Department, the statement said. Ad5-nCoV is being jointly developed by CanSino and a team led by military infectious disease expert Chen Wei from the Institute of Biotechnology under the Academy of Military Medical Sciences.

AMEX WINS CLEARING LICENSE FOR CHINA'S \$27 TRILLION MARKET



American Express Co. received approval to start bank card clearing services in China, making it the first foreign payments network to be allowed to process local currency transactions in one of the world's largest markets. The People's Bank of China granted a network clearing license to American Express's China joint venture, Express (Hangzhou) Technology Services Co., the central bank said in a statement. The company, which won initial approval in 2018, is required to start the clearing service within six months, according to the statement. The approval marks a win for the card giant amid rising political tension between the U.S. and China sparked by the coronavirus outbreak and a crackdown on Hong Kong. It underscores China's commitment to opening its US\$45 trillion financial markets this year, in a bid to attract foreign capital and support growth.

JPMORGAN GETS THE NOD TO TAKE FULL CONTROL OF CHINA FUTURES VENTURE



China's securities regulator approved

JPMorgan Chase & Co.'s application to operate the country's first fully foreign-owned futures business in an industry currently dominated by local players. JPMorgan in December applied to increase its 49% stake in its futures joint venture in China to 100%. Before the change, Shenzhen Wallace Rand Equity Investment Fund Management Co. Ltd. held a 50% stake in the venture, and a local investment company in Jiangsu held 1%. The China Securities Regulatory Commission (CSRC) said in a statement posted on its website that China will continue to deepen the opening of the futures market and bring in more qualified foreign institutions. China agreed to scrap limits on foreign ownership of futures companies starting 1 January as part of the gradual opening-up of China's financial sector to foreign players as pledged in its phase one trade deal with the U.S.

DIDI TRIALS 'ROBOTAXI' SERVICE



Ride-hailing giant Didi Chuxing (DiDi) on Saturday launched the trial run of self-driving ride service on designated test roads in the eastern metropolis of Shanghai. Users who have registered in advance on DiDi's mobile app can hail an autonomous vehicle for a free ride, as long as their points of departure and arrival are within the 53.6-km designated roads in Shanghai's Jiading District. DiDi said safety personnel have been deployed on the self-driving vehicles to respond to emergencies and take over the steering wheel if needed. In addition, DiDi has set up a safety center for monitoring the vehicle's operational status and provide remote assistance when necessary.

MASTER PLAN FOR HAINAN FREE TRADE PORT



China has released a master plan for the Hainan free port that aims to build the southern island province into a globally influential duty-free trading centre by the middle of the century. A trade port system focusing on trade and investment liberalization and facilitation will be "basically established" in Hainan by 2025, and become "more mature" by 2035, according to the plan jointly issued by the Central Committee of the Communist Party of China and the State Council. The plan aims to facilitate free trade, investment and cross-border capital flows in Hainan and says designated imported goods will be exempted from tariffs on the whole island. It lists plenty of work emphasis in periods stretching to 2035.

LUCKIN COFFEE ACCEDES TO DELISTING FROM NASDAQ



Luckin Coffee Inc. will be delisted from the Nasdag after it received two notices from the New York-based stock exchange over failure to meet listing rules, the scandal-plaqued Chinese coffee chain said Friday. The company originally scheduled a hearing on the issue for June 25. But the day before the hearing it withdrew the request and decided not to fight the Nasdag's delisting decision, according to a statement issued Friday. The company's shares will be suspended at the opening of business Monday. The stock plunged more than 55% to \$1.32 Friday morning. Luckin was listed on the Nasdag in May 2019 with an initial public offering price of \$17 each. At its peak, Luckin traded at just over \$50 a share with a market value of \$12 billion

CHINA COMPLETES ITS GLOBAL SATELLITE NAVIGATION SYSTEM



China launched the last satellite of the BeiDou Navigation Satellite System on Tuesday, marking the completion of the deployment of its own global navigation system. The satellite, the 55th in the family of BeiDou that means "Big Dipper" in Chinese, was launched at 9:43am (Beijing Time) and sent into the preset orbit by a Long March-3B carrier rocket from the Xichang Satellite Launch Center in southwest China's Sichuan Province. The satellite, designated to enter the geostationary earth orbit (GEO), was the last one of the BDS-3 system, which started to offer countries and regions along the Belt and Road as well as the world basic navigation service in December 2018. BDS is one of four global navigation satellite systems in the world. The other three global navigation systems are GPS of the United States, Galileo of the European Union, and GLONASS of Russia.

BIG CASH TRANSACTIONS OVER 100,000 YUAN WILL BE RESTRICTED



China has designated three pilot areas to regulate cash transactions in large amounts amid efforts to strengthen cash circulation management and curb illegal activities, the central bank said. Hebei Province will start the two-year pilot program in July, while Zhejiang Province and the city of Shenzhen will start the experiment in October, according to a plan released by the People's Bank of China, All three pilot areas will regulate cash transactions of 500,000 yuan or above for business accounts. For personal accounts, Hebei, Zhejiang and Shenzhen have set the thresholds of regulation at 100,000 yuan, 300,000 yuan and 200,000 yuan, respectively. The pilot program will encourage reservation-based cash withdrawals in large amounts, establish a system that records, analyzes and supervises large cash transactions, and prevent risks related to such transactions.

CHINA TIGHTENS INTERNATIONAL STUDENTS' APPLICATION FOR UNIVERSITIES, COLLEGES



China will further tighten international students' applications for undergraduate programs in Chinese

universities and colleges in an effort to uphold education fairness, said a recently released circular. The circular, issued by the Ministry of Education, noted that students whose parents are both Chinese nationals, or have one parent who is a Chinese national, and who have acquired foreign nationality at birth are qualified for admittance to undergraduate programs of Chinese universities and colleges on condition that they have a record of actually living abroad for more than two years in the last four years, in addition to other application requirements prescribed by the universities and colleges. Those who have immigrated and acquired foreign nationality are qualified for admittance into the undergraduate programs of Chinese universities and colleges on condition that they have held valid foreign passports or nationality certificates for at least four years and have a record of actually living abroad for more than two years in the last four years, in addition to other application requirements prescribed by the universities and colleges.

BUSINESS TRIP WITHOUT VISA TO CHINA IS COMING



The Hainan authorities intend to lift a number of restrictions and simplify visa-free travel by 2025, states the "General Program for the Establishment of a Free Port on Hainan", announced by the Chinese State Council. According to the state plan, the local administration will allow citizens of other states to come to the island without any preliminary formalities for business trips, visiting relatives and acquaintances, undergoing a medical examination or treatment, participating in exhibitions and forums, as well as sports competitions.

Biz Briefs Numbers

Tourists aboard cruise ships will be allowed to stay on Hainan for 15 days without a visa. According to the document, the Hainan authorities plan to gradually extend the period during which foreigners can stay on the island without a visa. At the same time, the authorities intend to ease border control.

2 HOURS TIME LIMIT FOR KTV



No more never-ending nights filled with singing and drinking at the karaoke bar for now, as new pandemic containment measures put a time limit as to how long people can stay inside entertainment locations and wangba (internet cafes). On June 22nd, China's Ministry of Culture and Tourism issued an adjusted version to earlier published guidelines on Covid-19-related prevention and control measures for theaters, internet cafes, and other indoor entertainment venues. According to the latest guidelines, it will not be allowed for Chinese consumers to stay at various entertainment locations and wangba for more than two hours. Singing and dancing entertainment venues, such as KTV bars, can only operate at no greater than 50% maximum occupancy. This also means that private karaoke rooms will be much emptier, as they will also only be able to operate at 50% capacity.

HK EXPECTED TO CANCEL BORDER CONTROL MEASURES IN PHASES

Hong Kong is expected to further relax social distancing restrictions and is considering cancelling border control



measures and 14-day compulsory quarantine in phases in the near future, as its COVID-19 epidemic situation continues to stabilize. Chief Executive of the Hong Kong Special Administrative Region (HKSAR) Carrie Lam said. Lam made the remarks in a Facebook post after the HKSAR government decided to roll out more measures to safeguard employment and create jobs to mitigate the impact of the COVID-19 pandemic. Small- and medium-sized enterprises (SMEs) make up over 90 percent of Hong Kong's business establishments and constitute the backbone of the society. The government has attached great importance to SMEs in relief measures to safeguard employment and support economy, as helping those enterprises survive means conserving strength for Hong Kong's economic recovery, Lam

FOREIGN TALENTS ONLY ACCOUNT FOR 0.04% OF POPULATION IN CHINA



The Ministry of Justice of China has published the full text of the draft version of the "Regulations of the People's Republic of China on the administration of permanent residence of foreigners". The regulations represent a concrete action for "widely attracting best talent from all over the world." According to statistics from several ministries and commissions,

the total number of international degree students in China has reached about 258,000 over the years. There are only a few hundred thousand foreigners working in China. The proportion of international talent in China's workforce is only 0.04 percent, the lowest in the world. In contrast, according to statistics from the Ministry of Education of China, in 2018 alone, 621,000 Chinese students went abroad to study, making China the world's largest source of international students and largest talent outbound country.

PEOPLE WHO "DEFAME" OR "STIGMATIZE" TCM WILL BE PUNISHED



Beijing traditional Chinese medicine (TCM) authorities addressed the controversy over draft regulations which appeared to indicate that people who question the efficacy of TCM would be punished, saying that it was a misinterpretation, and that they could revise or delete some clauses in the draft regulations in response to the controversy. Beijing is seeking public opinion on draft regulations on TCM which ban any person or organization from exaggerating the efficacy of TCM or using TCM to make improper profits, but also seek to punish those who "defame" or "stigmatize" TCM. The final version of the regulations is expected to be formally released in September.

China in the world

PANGOLIN OFFICIALLY REMOVED FROM TCM LIST

The latest version of the Chinese Pharmacopoeia for 2020 does not



include pangolins, which means the mammals will no longer be used in traditional Chinese medicine (TCM). The move came after China upgraded all species of pangolin from second-class to first-class protected animals because of their rapidly decreasing numbers due to over-hunting and habitat destruction. Pangolins are believed to be one of the world's most endangered animals and the world's most illegally trafficked mammal, according to TRAFFIC, an international wildlife trade research organization.

MANDATORY DIVORCE 'COOLING-OFF' PERIOD SPARKS ANGER



Chinese couples seeking a divorce must first complete a month-long "cooling-off" period, according to a new law that has sparked outrage over state interference in private relationships. The provision that requires couples filing for separation to wait for a month before their request can be processed—in a bid to reduce divorce rates--sparked widespread opposition when lawmakers first sought feedback last year. After it was passed, the law became one of the top trending topics on Weibo, with over 25 million views of posts using the hashtag "oppose the divorce cool-off period". The cooling-off period will not apply if one spouse is seeking divorce following domestic violence.

TICKETS FOR REGULAR-SPEED TRAINS GOING PAPERLESS



Railway passengers across China will wave goodbye to paper tickets as the country allows people traveling on normal-speed trains to use electronic tickets, according to the country's railway operator. The e-ticket system, which was previously limited to high-speed and intercity railways, will be promoted on rail lines running at normal speed, with over 1,300 such stations involved in the new arrangement, the China State Railway Group said. Passengers using the e-ticket system will be able to enter the station and check in with their ID cards and facial recognition without a paper ticket. The system will also reduce wait time and eliminate the risk of losing tickets or being sold fake tickets, it said, adding that the average time of ticket-checking will be shortened from 3.8 seconds per person to 1.3 seconds.

CHINESE MAN SENTENCED TO DEATH FOR MURDERING FOREIGNER



A Chinese man in Jiangsu Province was recently sentenced to death in a first-instance judgment for killing a foreigner. The man, surnamed Cong, 28, stabbed the foreign student in his chest with a knife on 11 July, 2018, following a quarrel. The attack ruptured the victim's heart and he bled to death, Jiangsu police said in a

statement later that day. The victim was a 26-year-old foreign student at a university. The police didn't release any further information and withheld his nationality and name. The guarrel ensued after Cong's scooter slightly rubbed against the expat, following which Cong bought a fruit knife from a nearby supermarket, and returned the spot to attack the expat, police said. The Nanjing Intermediate People's Court sentenced Cong to death for intentional homicide, turning down all arguments from the defence. Murder should be considered as intentional injury, the court held.

HEALTHY BABY IS BORN WITH ANTIBODIES AFTER HIS MOM CONTRACTED COVID-19



A baby in China has been born with coronavirus antibodies after his mother contracted COVID-19 when she was pregnant. The healthy boy was born to a woman who is originally from Hubei, where the pandemic started. Doctors said the child's coronavirus antibodies were 'a natural anti-virus ability' passed to him from the mother. The mother, known by her pseudonym Xiaoyu, tested positive for the coronavirus in early April despite showing no symptoms. Xiaoyu recovered from the deadly disease after being treated for ten days. She then gave birth to a healthy baby boy. The first-time mother received six nucleic acid tests after her labour and all the results came back negative.



ECONOMIC GROWTH TARGET FOR 2020

The government has decided not to set an economic growth target for 2020. Cases of the coronavirus are resurging in Beijing and the world economic and trade environment is not supportive of growth. Many factors are standing as an obstacle in the face of growth.

The Chinese economy shrank by 6.8% in the first four months of the year, which is the first contraction on record. In the second quarter the gross domestic product (GDP) growth may return to 2% or 3% as factories step up production.

China was struggling with a slowing economy before the virus hit hard, and it is currently trying to spend its way out of the slump. The country will pump 3.6 trillion yuan (\$500 billion) into its economy this year, to be spent on infrastructure projects and tax cuts. The purpose is to create around 9 million jobs and mitigate the fallout from the pandemic. This will likely drive a strong recovery in imports.

Some analysts are predicting that the central bank will be cutting both the interest rates and the required reserve ratio (RRR). This will lower the amount of cash that banks are required to hold in reserves, and will also make borrowing more affordable.

THE CHINESE ECONOMY IS STARTING TO RECOVER

The Chinese economy did show some recovery when stores and factories reopened after witnessing a nose-dive when most businesses closed during lockdown. Despite this, many consumers are still concerned about getting infected and they have not spent money on products. The economy seems to be dipping a second time before embarking on a more sustainable recovery.

China has turned its factories back on after bringing the coronavirus outbreak largely under control within its borders, but weak sales at stores raise fears about a possible second downturn. Imports in May declined 16.7% from a year earlier. It was the deepest contraction since January 2016, suggesting domestic demand remains sluggish.

Shipments of smartphones to stores in China went up 17% from a year ago, and the country's industrial production increased very fast in May, as it was 3.9% higher than last year. Those developments make economists more optimistic.

FACTORIES OUTPUT RISES LESS THAN EXPECTED IN CHINA

The Chinese economy shrank in the first three months of this year, while inventories of unsold goods are piling up. As the virus spreads, factories are producing clothes and electronics faster than consumers in China or overseas want to buy them. China's industrial output growth quickened to 4.4% in May from a year earlier. It was the highest percentage increase since December, but the gain was smaller than expected.

Sales have fallen for four straight months as shops, restaurants and other crowded places closed during the coronavirus pandemic. A collapse in export orders amid global lockdowns has left factories more reliant on domestic demand, which is recovering at a more sluggish pace. Overseas orders dwindled, and the retail sales fell more sharply than expected.

CONSUMER PRICES AND THE EXPORT OF GOODS

In May, the consumer price went up by 2.4% year on year, and down by 0.8%



month on month. The prices for tobacco and food went up by 8.5% year on year, those of clothing went down by 0.4%, articles and services for daily use increased by 0.1%, health care went up by 2.1%. The investment in fixed assets was 19,919.4 billion yuan. It decreased by 6.3% from a year earlier.

The total value of exports and imports of goods in the first five months of the year was 2,469.6 billion yuan. This was a decrease of 4.9% year on year. The total value of exports was 1,456.2 billion yuan in May, which is a 1.4% increase, and the total value of imports was 1,013.4 billion as it went down by 12.7%.

There was a study increase in investment in education and the healthcare sector. There was also growth in production of information transmission, real estate, and financial intermediation services. The wholesale, accommodation, and retail trades suffered a decline from a year earlier. The total value added of the industrial enterprises above the designated size grew in May, indicating that the production machine is still working.

CONCLUSION

There are still many challenges standing in the way of recovery, but China is doing all it can to climb out of that economic decline. In the remainder of 2020, the Chinese economy would need to show strong recovery, and the recent signs are positive.

It is better to ease restrictions on financial services in Hong Kong and adjacent areas of mainland China in an attempt to increase the economic growth there. China has to step up government spending to offset a possible further slowdown. Given the higher unemployment, China has lost some of the progress achieved on combating poverty. It will need to resume the battle to ensure the prosperity of the society.

罕见!2020 年不设 GDP 增速具体目标

政府已决定不设定 2020 年的经济增长目标。 在受新冠病毒重创之前,中国一直在与经济 放缓作斗争,而中国目前正努力摆脱萧条。 今年政府将向市场注入 3.6 万亿人民币(约 合 5,000 亿美元),用于基础设施建设和减税。

中国经济开始复苏

经历了大多数企业停业关闭之后,中国的经济确实出现了复苏。但销售疲软引发了人们对可能再次出现下滑的担忧。中国5月出口按美元计价同比下降3.3%,由于市场预期的下降7%,进口同比下降16.7%,为2016年1月以来最大降幅,不及市场预期的下降9.7%。但5月份中国的工业生产增长非常快,比去年增长了3.9%,这使经济学家对经济复苏表示乐观。

消费价格与商品出口

5月份,全国居民消费价格指数 (CPI) 同比上涨 2.4%,环比下降 0.8%。扣除食品和能源价格的核心 CPI 同比上涨 1.1%,涨幅与上月持平。从数据走势来看,CPI 同比涨幅近几个月内呈现逐步回落走势,为货币政策打开更大空间。5月份,货物进出口总额 24696亿元,同比下降 4.9%。其中,出口 14562亿元,增长 1.4%;进口 10134 亿元,下降12.7%。进出口相抵,贸易顺差 4427 亿元,比 4 月份扩大 1246 亿元。





China's economy suffered immensely over the course of the outbreak, no different from the rest of the world.

China's GDP went down by 6.8% year-on-year during the January—March period, including a massive drop of 39.2 in Hubei province where the epidemic originated.

However, China has managed to take control over COVID-19, re-opening the economic gateways, while the other countries are facing the worst of the virus, with their governments struggling to manage the crisis.

China is now looking at putting its economy back on track for the rest of 2020 and beyond, and appears to be well-positioned to achieve its goal with ambitious economic policies set to be released.

WHAT DOES THE ECONOMY IN CHINA LOOK LIKE TODAY?

As per official surveys, 99% of China's large industries and 84% of small-and medium-sized businesses had reopened by mid-April. Industrial production grew by 3.9% from a year earlier, recovering from a recent drop. However, the growth rate is twice as fast as most economists expected.

China's investment in fixed assets such as machinery and land, property investment, and infrastructure investment rose in April, even though they have still not reached the pre-pandemic levels. However, the recovery on the demand side appears to be slower.

Retail sales in April fell by 7.5% year on year. The battle against the coronavirus all over the world has resulted in a decline in overseas demand as well.

Many are looking to China's parliamentary "Two Sessions" to provide more fiscal measures to stimulate domestic consumption due to the uncertainties abroad.

The official urban unemployment number in April is 6%, slightly higher than 5.9% in March, given that this number may not include everyone who is out of work

A positive impact of this pandemic, however, is the expansion of China's digital economy with online sales, teleconferencing, and online entertainment amid social distancing conditions, although China was already a digital leader, accounting for 45% of global e-commerce transactions.

FORTHCOMING AMBITIOUS ECONOMIC POLICIES

Economists expected China's GDP to grow by around 6% in 2020 before the outbreak of the pandemic.

According to statements made by Chinese officials, they may be laying the groundwork to achieve the targets by 2021, or by the end of 2021, as the previously set targets no longer seem to be practical.

China is focused on developing new

infrastructure, such as 5G networks, NEV charging stations, energy efficiency programs, and other initiatives that will help rebuild its future economy.

KEY ANNOUNCEMENTS MADE IN THE TWO SESSIONS MEETING 2020 REGARDING CHINA'S ECONOMIC RECOVERY.

Growth target

The GDP growth target in China is not just a predictor of growth output but also an input signal of forthcoming government credit and spending.

However, it was announced that due to the high level of uncertainty caused by COVID-19, China would not set a GDP growth target for 2020, making this the first time the government has not set a target since records began in 1990.

While it was also stated that the government will take strong measures to support employment, there remains uncertainty over how far they will go to stimulate the economy, possibly signalling that the government is prepared to accept a low level of growth in 2020.

Fiscal stimulus

A fiscal stimulus package of almost RMB 3.6 trillion (US\$506 billion) was announced to lead China's economic recovery following the COVID-19 pandemic. Accordingly, the government is increasing the budget fiscal deficit to an all-time high of 3.6% of GDP, compared to 2.8% in 2019.

As a part of this package, the government will issue special treasury bonds to the value of RMB 1 trillion (US\$140 billion) and increase the local government special bond quota to RMB 3.75 trillion (US\$27 billion), representing a RMB 1.6 trillion (US\$225 billion) increase year-on-year.

This is a key source of funding infrastructure, and is a method the Chinese government generally utilizes to stimulate growth.

Government planners are also hoping that the stimulus will help employment and, as a result, social stability. The Chinese government is looking at creating nine million new urban jobs in 2020.

China is limited by the high levels of debt it accrued to navigate the recent crisis. The central government has been leading a multi-year debt de-risking campaign and has attempted to reduce reliance on government spending for growth in order to eliminate this issue.

Other policy announcements

It was announced that China will establish more free trade zones (FTZ) and bonded areas in central and western regions, further shorten the negative list for guiding foreign investment, cut more taxes, and continue pushing the Belt and Road Initiative overseas.

HOW WILL THE GLOBAL ECONOMIC RECOVERY PLAY OUT?

The global economic outlook is highly uncertain due to the unpredictable nature of COVID-19. Despite the contraction in China's economy during the first quarter of 2020, the IMF still projects the economy to grow by 1.2% for the year. And for 2021, the IMF predicts China's economy will grow by 9.2%.

in Wuhan, China, and spread globally. Many conspiracy theorists or people who want a spicy story claim that the virus was intentionally released as a biological warfare weapon and was specially created for this very purpose. A renowned scientist in microbiology, immunology and paediatric infectious diseases at the University of Iowa, when interviewed, said that a good biological weapon should be well known and understood. Little was known to the world about this virus, and according to him, this makes it a bad candidate, and therefore highly unlikely to have been released as a means of mass destruction. He said it is "virtually impossible" to create such a virus from scratch in the lab, and all the evidence so far points to the fact that the origin is zoonotic and completely natural. Other scientific evidence also suggests that the virus was not 'engineered' in some lab.

It is a well-known fact that the virus originated

Another theory circulating is that the virus was released as a result of a breakdown of the biocontainment in the lab of Doctor Shi Zhengli (Ph.D., director of the Centre for Emerging Infectious Diseases at the Wuhan Institute of Virology). These accusations not only have no evidence-based merit, they have also been denied by both the lab itself and various scientists across the world. Evidence instead points out that the genetic sequences of the Novel Coronavirus are not the same as the ones which were being studied in the lab, where the work they were doing was transparent, published and well known.

Flinders University published results of a study indicating that as the virus appears to infect humans much more potently than it does bats, there is little chance that it came from bats directly, and an intermediate host had therefore played a role. So the conclusion is that the virus 'jumped species' and 'mutated' to eventually infect humans. Some scientists have found evidence that the origin may not be bats at all, but pangolins.

It is noteworthy that this is not the first time such an incidence of a virus 'jumping species'

or 'spill over' has occurred. Measles, smallpox, SARS, and dengue fever all originated from animals and resulted in an epidemic/pandemic in some period of history.

Numerous studies are underway across the globe, and a race is on to find the true origin, as that would help in the development of a vaccine. But as trials are still going on, there is a scarcity of published data regarding these genetic studies. A lot of information out there is speculation, and the truth is that the exact origin of the virus remains a mystery to this day.



His story of success continues to inspire the world. He is an innate genius whose entrepreneurial skills were revealed to his family at a very young age. As a young boy, he chose his path and recognized his leadership skills. He went to sleep every day full of ideas about what he wanted to accomplish the next day.

THE HARD-WORKING YOUNG BOY WITH INBORN TALENT

Born in the United States into a family of farmers, and the son of a poor shepherd, he had no means to get much education. At a very early age, he started supporting his father in farming and looking after the family. His father gave the children plenty of freedom and encouraged them to trust their own intuition, which made them self-sufficient at a very young age.

He was unstoppable, and at a the age of 13 was already striving to excel. His first business endeavour was to produce lettuce on his father's farm, which could bring in \$2,000 as profit. Thus began the very first business attempt of the world's greatest entrepreneur.

THE EARLY JOURNEY OF THE WORLD'S MOST SUCCESSFUL ENTREPRENEUR

The most significant turning point of his life began when he enlisted for missionary work in the Mormon church in New England. Those two years changed his view on the world and inspired him to do something bigger, rising above his ordinary family background. He decided to pursue his studies, which he had stopped halfway. He graduated from Weber Junior College and then went to the University of Utah

During his college days, he sold woollen underwear to lumberjacks to pay his tuition fees. He also taught theology at Weber college in exchange for tuition fees. The president of the college, who was his former high school teacher, assigned him a job on the campus after graduation, but he had already made up his mind to do something else, so he declined the offer.

HUMBLE BEGINNINGS OFTEN LEADS TO GREAT VENTURES

While thinking about a business strategy, he was clear about its success. In 1927, he saw a business opportunity in selling cold soft drinks; seeing a cart peddler making brisk sales of refreshing drinks and ice creams in Washington DC prompted him to secure the franchise of A&W Root Beer for Washington DC., and with a partner, he started a nine-stool root beer stand, which was his first business venture.

He then began to find new methods to expand his small business by engaging in several promotional activities. While the scorching summer benefited the soft drink business, winter made him think about restructuring his business. Acquiring permission from A&M, the shop began to serve food. His wife tried Mexican recipes for their customers, and as expected, it started to show results.

Soon, their focus shifted to catering, which resulted in the family restaurant franchise named Hot Shoppe, Inc. Promotion is important, and he took the initiative by doing several promotional activities to attract customers. His family restaurant chain began to expand to more locations.

THE INNOVATOR WHO SAW POSSIBILITY IN EVERYTHING

A successful business mind will always be innovative, and a genius observer will see possibilities in circumstances that seem invisible to the eyes of others. Even after establishing the restaurant chain with his efforts, he aspired to do more and was always keen to experiment with new ideas.

With the wholehearted support of his wife, the business began to grow, and in 1928 they started the first drive-in restaurant in Mississippi. When the eighth Hot Shoppe opened near the Hoover National Airport, he noticed that the passengers stopped at the restaurants to grab food boxes to eat from on the plane. Recognizing an in-flight opportunity, he began to sell meal boxes to the airlines, which led to the setting up of airline catering services.

天赋异禀的小男孩

他出生于美国犹他州的 Marriott Settlement , 是一个贫穷的牧羊人的儿子。他小时在自己家的小农场上帮助父母种植甜菜和喂养牲口。他的经商才能似乎是天生的。在他 13 岁的时候就开始了自己的第一单生意。那个时候他招集来自己的兄弟姐妹在农场上一块相对贫瘠的土地上种植生菜。在夏天结束的时候,这些生菜为他带来了 2000 美元的收入。他把这第一笔钱全部上缴给了父亲。也因此赢得了父亲的信任。

外出闯荡

他对于雄伟山脉和广阔空间的向往注定他不会一辈子生活在自己家的小农场。1921年,他返回了犹他州,开始了在犹他大学的学习生活。在大学期间他开办经营各类小公司来挣取学费,他甚至曾经向伐木工人卖过毛纺的内衣。

瞄准商机

大学毕业以后,他来到几千英里以外的美国首都华盛顿,开始计划自己未来的生意。他走遍了华盛顿的每个角落,发现乐啤露的市场非常大。因此,他从A&W获得乐啤露的代理销售权。此后,他和合作伙伴筹集到6000美元用于购买机器设备和租赁店面。在1927年的5月20日,仅有九个座位的乐啤露小店开张了。就在小店开张的两个星期后,他又返回了犹他州完成了预示他生命中又一个重大变化的事情——与Alice Sheets 结为了夫妻。

一切皆有可能的创新者

1928年,他在密西西比州开设了第一家自助餐厅。同时他开始向航空公司出售餐盒,从而建立了航空公司的餐饮服务。一年之内,该服务扩展到了每天20个航班的餐饮销售。除了提供机上餐饮外,他还为多个场馆,学校和学院提供服务。

创建万豪

1957年,他在维吉尼亚州阿林顿市1号公路上开设了万豪家族的第一家酒店——双桥汽车酒店,至此万豪家族才从餐饮业进军酒店业。从犹他大学毕业并服完两年兵役后,他回到了家乡,并接手了家族刚刚建立的第一家酒店。很快他们发现做酒店远比做餐饮赚钱,于是将重心转向了酒店业。

有爱心的雇主

作为一个亲力亲为的管理者,他喜欢造访公司旗下的每个店铺和员工一起吃饭,与他们谈心。"去关心你们的员工,你们的员工就会去关心你的顾客,"这是他经常和公司的管理人员说的一句话。这也是万豪公司一直恪守的公司文化。

万豪国际集团

他就是万豪酒店的创立者 J. Willard Marriott (约翰·维拉德·万豪) 先生,目前,万豪国际集团发展已然成了全球最大的酒店集团之一。公司目前共拥有31个酒店品牌,在124个国家和地区拥有超过6100家酒店,旗下汇聚了 JW 万豪、丽思卡尔顿、喜来登、威斯汀、W 酒店等多个著名酒店品牌,年营业额超过200亿美元,多次被世界著名商界杂志和媒体评为首选的酒店业内最杰出的公司。

Within a year, the service expanded to selling meals to 20 daily flights. Apart from in-flight catering, he offered his services to several venues, schools, and colleges.

By the time World War II broke out, he owned 24 Hot Shoppe family restaurants in several parts of the country. When the war halted the chance of growth, he found a new direction by starting cafeterias in several government buildings and factories. After the war, the restaurant chain progressed further.

The company went public in 1953, and by that time, they had a total of 56 restaurants which served millions of customers every year.

CLIMBING THE LADDER TO MARRIOTT INTERNATIONAL, INC.

Continuing the success in the hotel/restaurant business, he shifted focus to the business of lodgings. In 1957, the company opened its first motel, Twin Bridges Marriott, in Virginia, and soon established two other hotels. By this time, he had become a millionaire, and the Marriott group had become the largest hotel business in the world. He changed the name of the company several times; it was Marriott Hot Shoppe Inc. in 1964, and Marriott Corporation in 1967.

The company also took over two big chains, Big Boy family restaurants in 1968, and Roy Rogers family restaurants the next year. They also ventured into the cruise ship and theme park businesses. However, the hotel business became the primary focus of the company.

A CARING EMPLOYER

He maintained excellent relationships with the employees and always gave priority to their requirements. He believed that if you treat your employees well, they will take care of customers well, which is the prime principle that is still followed by the company.

He even visited his employees when they were sick and provided them with the necessary help. He visited all the branches of the business four times a year and made sure everything was going well, and he continued to do this after his retirement and until his death. Today Marriott International Inc. is at the top of the list for the most diversified employer, and is among the world's most innovative enterprises.

THE BRAND NAME MARRIOTT INTERNATIONAL, INC.

Marriot International, Inc. became immensely popular, and reached top position before his death. By that time, the company owned over 1,400 restaurant chains, 143 hotels and resorts worldwide, catering services for 150 airlines, and two theme parks. It had approximately 150,600 employees, and earned more than \$4.5 billion in revenue annually.

In 1993, the name of the company changed to Marriott International, Inc.. The name change drew its inspiration from the motto 'great companies are built by people who never stop thinking about ways to improve the business,' which shaped the company as one of the most notable brand names in the hospitality and hotel industry.



Maluku has been a hideout for many travellers in search of full-grown spices. Located to the south of Sulawesi, Maluku attracts tourists with its beautiful gardens, history and natural

popularly known as the Spice Islands, a land with the best attracting many tourists. Since the island is located in a water, luscious gardens, and two national parks have everything for the visitor who wants to escape from hectic modern life. The best season to visit the area is November to March, so plan your trip accordingly.

Getting a visa to visit Indonesia is relatively easy, and there

are many types of visas available for tourists. Depending on the nature of the visit, you can apply for a single-entry visa or multiple entry visas. All passengers should have a valid passport with a minimum of 6 months' validity, and should also have a return or onward ticket.

0 days free entry visa for 169 nation

Indonesia offers a 30-day free entry visa for nationals from the 169 countries which are on the visa free list. The tourist should have a return ticket or onward ticket, and this visa is non-extendable. Travelers who want to take advantage of the visa can apply to the respective Indonesian embassy in their home country by courier, or by visiting the embassy in

ival for 68 nationals

Another option is visa on arrival, which applies to citizens from 68 listed countries. It is a 30-day visa, extendable for an additional 30 days, but not beyond that. Tourists should hold a passport with a minimum of 6 months' validity as well as return or onward flight tickets.

Multiple entry visa

Tourists can also opt for a multiple-entry visa, which is suitable for frequent travel to Indonesia.

Visitors are allowed to enter Indonesia several times before the visa expiration date (the visa is valid for a year), and may stay up to 60 days.

For the multiple entry visa, the passenger needs to apply through the Indonesia embassy or consulate of the home country.

The cost of a single-entry visa is \$45, and a multiple entry visa is \$100. The validity of the visa is 90 days from the date of issue.

Overstay penalty

Overstay penalty is IDR 1,000,000 per day, and maximum permitted overstay with penalty is 60 days. Staying beyond 60 days will be considered illegal, and is an offense punishable with 5 years' imprisonment or a fine of IDR 5.000.000.000.

HOW TO REACH THERE?

Tourists can visit Maluku by air and sea. Depending upon the country that you reside in, you may choose the easiest option from the followina:

Apart from Sultan Baabullah Airport in Ternate and Pattimura Airport in Ambon, a tourist can also get flight connections from Pitu Airport in Morotai island and Karel Sadsuitubun Airport in the Kei Islands. Regular flights are available from Makassar, Manado, and Jakarta to Sultan Baabullah Airport and Pattimura Airport. Once you've arrived at the airports, it will be easier to explore the region with the local transport service.

By sea

Excellent ferry connectivity is available to Maluku from different islands. The Indonesian National Ferry service, 'PELNI,' and other private ferry service providers conduct regular services from Ambon, Ternate, Banda Naira, Tual, and many other ports. Apart from the ferry services, you can also find speed boat services between the islands.

How to go around Timor-Leste?

You can find several types of transport facilities, like buses, ojeks, and bemos, to move around the island. At the Ambon airport one can hire a car with a driver and petrol, which will cost around IDR 600,000-750,000 per day. Alternatively, bike rentals are available for IDR 150,000 per day. You can reach out to any of the local transport stations in Maluku, and they will provide you with the vehicle you require. If you wish to go the traditional way, you can opt for a becak (rickshaw) in Ambon, or a local minibus which takes you to every attraction in the area.

Ambon

Ambon is the most developed island in Maluku, and its history dates back to the Dutch Colonial period. During the colonial struggle, the war took its toll on Maluku. Most of the historic monuments got damaged; however, Fort Benteng Victoria weathered all the atrocities and all the changes that the city had to take on. Since the fort is a 'no photography' zone, it would be better to have prior permits to avoid any bad experiences.

Pulau Seram

Pulau Seram is the main island and the largest in Maluku Island province, engulfed by a group of islands, and located on the northern side of the small Ambon Island. Its rich flora and fauna are among the reasons why tourists are attracted to this beautiful place. The island is a home for 14 endemic species of birds. You will have the rare chance to see the grey-necked friarbird, salmon-crested cockatoo, Eclectus parrot, etc.. It is the habitat for 117 species of birds, some of which are endangered.

Dense forest makes it a safe home for many mammal species. You can find about 38 species here, of which 9 species are endemic. Commonly found mammal species are murid rodents. Australasian marsupials, Seram bandicoots, etc..

Pulau Seram is a beautiful location and home to many attractions around the main city of Mashoi. Sites like Sangar Budaya Seram museum and the less inhabited hinterlands of the island will give you a rare opportunity to meet the Nua-ulu tribes.

Tanimbar Islands

Tanimbar Islands, also known as Timur Laut, is a cluster of islands, part of the Lesser Sunda Islands. Yamdena, the largest island, is ideal for beach lovers. The island's identity is displayed in its cultural uniqueness, and the villagers are skillful in creating carved wooden items and ikat cloths. Like many island communities in Indonesia, Tanimbar inhabitants have unique music and dance that are worth enjoying up close. Apart from the pristine beaches, they are also home to rare endemic birds and animals.

Manusela National Park

One of the main national parks in Maluku is the Manusela National Park, sprawled over 189,000 hectares, located on the Seram Islands. It is famous for evidence of the evolution of a range of indigenous species. At the park, you will encounter 2,000 different butterflies, along with around 120 species of birds—a rare treat to soothe your soul.

Lava Flow

A main attraction in the Banda Islands, is Lava Flow, a dream diving location just in front of the Gunung Api volcano. It is famous for its exquisite table corals which can grow up to four meters in size, thus attracting aquatic life such as sharks and mandarin fish.

Pulau Hatta and Pulau Banda

The Banda Islands are known for scuba diving and snorkelling, and you will find gorgeous coral gardens as you dive. Some of the famous diving spots here include Pulau Hatta and Pulau Banda Besar. Spend your leisure time on the pristine beaches watching the turquoise water whispers.

CONSTRUCTION PROJECTS BOOST THE ECONOMY

With the economy flagging, the national government has announced a number of large construction projects to help stimulate the economy. I recently visited one in Tianjin, the National Exhibition and Convention Centre located in Tianjin's Jinnan District. To be fair, this project has been under planning and construction for a few years, but it is part of the government-led investment theme. This project raised a number of questions I've had about these investment-led projects, but it also helped answer some questions I've had about other projects the government previously built.

ACTIVITY GENERATES GDP

Whenever anyone asks if a construction project is viable long term, as in, "who is going to use this?", I am usually asking that question too, but I am also then reminded of a lesson I learned in economics years ago, and that is that "activity generates GDP (Gross Domestic Product)." Professors like to say that if workers are hired to dig a hole and then fill it in, that has generated GDP or measurable economic activity. That was never very satisfying to me. And while it doesn't answer the question about the long-term success of a project, it does help explain that the construction project itself, if

completed, has already achieved part of someone's GDP target. By generating salaries for workers and by consuming construction materials, it has helped to boost the economy.

SATELLITE CITIES AND UNIVERSITY TOWNS

Until recently, calling a city a "university town" would indicate that there are a substantial number of students in that city as compared to its local population base. Austin in Texas, Heidelberg in Germany and Wuhan in China are examples. These cities often benefit from a cluster of universities or institutes of higher learning which generate good jobs, more sports and entertainment options per capita and a thriving bar and restaurant scene. And in most cases, the schools themselves

benefit from their surroundings. A decade ago, attending Nankai University or Tianjin Foreign Studies University meant living in the heart of a big city and being surrounded by buildings nearly a century old. So I was baffled a number of years ago when Tianjin started building "university towns" that were clusters of schools located on the outskirts of the city, and moving undergraduates to these campuses. In Tianjin there are at least four such clusters I can think of. A particularly large one is located east of the city in Jinnan District, the Haihe Education Park which has half a dozen schools.

I personally enjoyed my years at a university, partially as a result of its urban location, and I would certainly not choose a school located in a brand-new purpose-built campus located far from the city. However, as Tianjin built these far-flung campuses, they generated activity, and in the urban places that once housed students, a number of new, large projects, in some cases tall apartments and office buildings, have been built. These, again, generated economic activity.

INFRASTRUCTURE

I have spent hours poring over maps of Tianjin and am always curious and excited to discover what is being built. And I have a soft spot for trains and subway systems and so love to see these networks expanding, but I sometimes wonder about specific projects. Did you know, for instance, that Tianjin has eight high-speed rail stations in operation? One, Junliangcheng North Station (军粮城 北站) has always been a mystery to me. And where is that Line 1 subway extension to the east going? And did we really need Tianjin Avenue (天津 大道)? Well, actually, in the latter case, it does make sense to have a direct route from central Tianjin to Binhai's Yujiapu that doesn't drag you through the various industrial sites in Hedong and Dongli. And what was the side effect of building these roads, rail lines and metro systems? You guessed it, economic activity and jobs.

SEEDING AN AREA


Besides the initial economic activity generated by their construction, many of these big infrastructure projects seed an engine of growth for their immediate surroundings. In terms of these remote college campuses, jobs are created for catering staff, security quards, cleaning staff and delivery folks. Additionally, people with good jobs, such as professors, spend more time and potentially money in these communities as they stop for gas, a meal or a coffee, or even decide to move to cheaper housing close by. And eventually, new restaurants, bars and entertainment options will be created to cater to the young and curious students.

THE CONVENTION CENTRE

Now how about more details of this new National Convention and Exhibition Centre that I mentioned earlier? The first phase is slated to open in June of 2021. Once the entire project is completed, it will have 1.34 million square metres of built space. This will include exhibition and meeting space as well as two office towers, a Marriott and a Four Points hotel, and a large retail area.

The meeting and exhibition space on its own is bigger than the Meijiang Convention Centre. It is a sight to behold. Upon arrival it looks like an airport terminal with its high roofs and vaulted ceilings.

And how do you get there? It is located along the still relatively new Tianjin Avenue between central Tianjin and Yujiapu. There are also two stations on the east extension of subway Line 1 (Beiyangcun or Guozhan lu stations) (北洋村或国展路). And although not many trains stop there right now, the high-speed rail station Junliangcheng North Station (军粮城北站) is curiously close by.



A GLIMPSE OF KFY FISCAL AND TAX POLICIES IN CHINA'S **GOVERNMENT** WORK **REPORT** IN 2020



On 22 May 2020, Premier of the State Council delivered the <Report on the Work of the Government> ("Report")¹ at the third session of the 13th National People's Congress (NPC). The Report reviews China's economic and social development work in 2019 and the first few months of 2020 and sets forth the main development targets and the overall plan for the next stage of work.



China has continued implementing proactive fiscal policies and a larger scale of taxes and levies reduction in 2019, with a major focus on relieving the tax and levy burden of the manufacturing sector and small and micro enterprises (SMEs). The tax and levy reduction measures which have been introduced includes: further lowering the Value-added Tax (VAT) rates, reducing the percentage of basic pension insurance contribution paid by enterprises, implementing the general preferential tax policies for SMEs and revising the Individual Income Tax (IIT) Law which encompass six types of special additional deductions. It is stressed in the Report that China has reduced taxes and levies in the total amount of RMB 2.36 trillion during 2019, exceeding the original target of around RMB 2 trillion, with the manufacturing sector and SMEs benefiting the most.

In response to the impact of the COVID-19 pandemic on the macro-economy and market players, the Report proposes to further reduce taxes and levies and aggressively implement current policies in conjunction with institutional arrangements to create a more enabling environment and help market players overcome difficulties and achieve development. The major taxes and levies reduction policies include: continue implementing reduction of VAT rates and the percentage of basic pension insurance contribution paid by enterprises, extending the expiry date of policies introduced earlier, such as: exempting medium enterprises and SMEs from contributing basic pension insurance, unemployment insurance and work injury insurance; reducing or cancelling VAT for small-scale taxpayers; exempting VAT on certain services; and reducing or cancelling civil aviation development fund contributions and port development fees, to the end of 2020. It is expected that these measures will additionally reduce the burden of enterprises by over RMB 2.5 trillion for the year.

In this article, we summarize the tax and levy reduction policies to be implemented in the second half of this year and share with you our observations.

HIGHLIGHT ONE: CONTINUING THE INSTITUTIONAL ARRANGEMENTS REGARDING VAT REDUCTION

Since the completion of the B2V Pilot Program in 2016, deepening the VAT reform and optimizing the structure of VAT rates has been the biggest fiscal and tax highlight of the Report in every year. In recent years, China has released a series of measures to deepen the VAT reform, including: simplifying and reducing VAT rates, further perfecting the VAT credit chain, implementing the refund policies for incremental excess input VAT and accumulative input VAT credit balance, optimizing the export VAT refund policies for goods and services and further improving the preferential VAT policies, etc. Continued implementation of the measures to deepen the VAT reform will have a cumulative effect on sustaining the reduction of tax burdens of enterprises, as well as help enterprises overcome difficulties and maintain sustainable economic development. It should be noted that the Report proposes to continue implementing reductions of VAT rates instead of adjusting the structure of VAT rates, which indicates that, in addition to the zero VAT rate, China may continue to adopt the prevailing three VAT rate brackets of 13%, 9% and 6% in the near future.

In November 2019, the Ministry of Finance (MOF) and the State Taxation Administration (STA) jointly released the consultation draft of China's VAT Law, which retains the prevailing three VAT rate brackets as well. Based on the background of reducing taxes and levies in recent years and the requirement of "simplifying the VAT rate brackets from three to two" by the State Council, it is well-worth monitoring whether the VAT rate brackets will be adjusted and simplified while China is moving forward with the enactment of the VAT

HIGHLIGHT TWO: EXTENDING THE VAT INCENTIVES FOR THE PREVENTION OF **COVID-19 OUTBREAK**

In response to COVID-19 outbreak and to support enterprises and economy development, the MOF and STA jointly released Public Notice [2020] No.8¹ and Public Notice [2020] No.13 in February 2020 to clarify certain preferential tax treatments as

- Income derived from transporting key pandemic prevention materials are exempted from VAT;
- Income derived from public transportation services, consumer services and certain express delivery services are exempted from VAT;
- Key pandemic prevention manufacturing companies are allowed to apply for the refund policy of VAT credit balance on a monthly basis

• From 1 March to 31 May 2020, small-scale VAT taxpayers in Hubei province have been granted temporary exemption of VAT and those in other regions in China have been granted a reduced levy rate of 1%. For certain items subject to VAT prepayment, the levy rate is also reduced at 1%.

The Report proposes to extend the implementation period of VAT reduction for small-scale VAT taxpavers and VAT exemption on certain services, such as public transportation, catering and accommodation, tourism and entertainment, and cultural and sports to the end of 2020. This extension further supports small-scale VAT taxpayers and consumer service taxpayers that are greatly affected by the pandemic in resuming work and production.

HIGHLIGHT THREE: SUPPORTIVE TAX AND LEVY POLICIES FOR MEDIUM ENTERPRISES AND SMES

Continue to reduce social security contributions paid by medium enterprises and SMEs: In order to support enterprises in the resumption of work and production, as well as stabilize and expand employment, the MOHRSS, MOF and STA jointly issued the <Notice to Cut Social Security Contributions Borne by Enterprises by Phases> (MOHRSS Fa [2020] No.11²) in February 2020, providing that from February 2020, enterprises of different sizes in different regions can enjoy reduction or exemption of the basic pension insurance, unemployment insurance and injury insurance (hereinafter referred to as "social security contributions"). The Notice also clarified that medium enterprises and SMEs were exempted from social security contributions, with the exemption period of not exceeding 5 months (i.e. due to expire in June 2020).

To help medium enterprises and SMEs get through this challenging time and to ensure employment and people's wellbeing, the Report proposes to extend the exemption period of social security contributions by enterprises to the end of 2020, which will further relieve their labor cost burdens. We anticipate that the MOHRSS, MOF and STA will issue a new circular in accordance with the Report to implement this policy before the end of June.

Postpone income tax payments of SMEs and sole **proprietors:** Apart from exempting medium enterprises and SMEs from paying social security contribution, the Report also mentions that the income tax payments of SMEs and sole proprietors will be postponed to

2021. This initiative will have a positive effect on relieving the cash flow pressure of SMEs and sole proprietors. It is expected that the MOF and STA will issue relevant regulations to clarify the applicable conditions, the specific procedures, etc., in relation to postponing income tax payments by SMEs and sole proprietors.

THE TAKEAWAY

"Taxes and levies reduction" has been a key phase of China's macro-economic control and proactive fiscal policies in recent years. In response to the changes in domestic and international economic landscapes, China has successively launched a series of policies and measures to reduce taxes and levies, so as to support the development of the real economy and vitalize market players. The total amount of taxes and levies reduction exceeded RMB1.3 trillion in 2018. and that amount reached to RMB 2.36 trillion in 2019. The 2020 Report further sets a target of over RMB 2.5 trillion for reducing taxes and levies for this year. These policies will relieve burdens on various market players, especially SMEs, which can stabilize employment, ensure living standards as well as keeping the fundamentals of the economy stable.

The <Opinions of the Central Committee of Communist Party of China ("CCCPC") and the State Council on Optimizing the Socialist Market Economy System in New Era>³, which was issued recently, also pointed out the direction for China's next-step tax reform, including: deepening the tax reform, advancing the direct tax system and gradually increasing its proportion, moving the levying of consumption tax (CT) to later stages, establishing and optimizing the aggregate and scheduler IIT regime, steadily promoting the enactment of the property tax law, improving


2021. This initiative will have a positive effect on relieving the cash flow pressure of SMEs and sole proprietors. It is expected that the MOF and STA will issue the local tax regime, adjusting and refining the local tax system to foster the sources of local tax revenue and to steadily expand the power of local tax administration.


So far, 9 out of the prevailing 18 types of taxes have been enacted (including Vehicle and Vessel tax, Environmental Protection Tax, Tobacco Tax, Vessel Tonnage Tax, Corporate Income Tax, Arable Land Occupation Tax, Vehicle Purchase Tax, IIT and Resource Tax), while the enactment of the other 9 types of taxes is undergoing. The draft Deed Tax Law and the draft Urban Maintenance and Construction Tax Law were passed to the Standing Committee of the NPC for the first review and also were issued to solicit public opinions. The MOF and STA jointly released the consultation drafts of the VAT Law and CT Law for public comments. It is also reported that the draft Stamp Duty Law is under legislative review by the Ministry of Justice. We note that in February 2020, the MOF issued a legislative work plan for 2020 which also mentioned that it is striving to complete the drafting of VAT Law, CT Law and Tariff Law for submission to the State Council in due course.

Under the current situation of great uncertainty due to the COVID-19 pandemic and the global economic and trade environment, the Report proposes to pursue a more proactive and impactful fiscal policy to support the reduction of taxes and levies and to release positive signals relating to helping market players to overcome difficulties, coordinating the advancement of pandemic control as well as promoting economic and social development. We will closely monitor the interpretations on the taxes and levies reduction measures covered in the Report and the upcoming circulars, and share with you our observations timely. B

2020 GOVT WORK REPORT





2020 年《政府工作报告》财税政策抢先看

2020年5月22日,国务院总理在第十三届全国人民代表大会第三次会议上作了《政府工作报告》¹ (以下简称"报告"),回顾了2019年和今年以来中国经济社会发展工作,并对2020年发展主要目标和下一阶段工作进行总体部署。

2019年中国继续实施积极的财政政策,实施更大规模的减税降费,重点降低制造业和小微企业税费负担,推出了包括进一步降低增值税税率,下调城镇职工基本养老保险单位缴费比例,落实小微企业普惠性减税政策和修订后的个人所得税法及6项专项附加扣除在内的多项减税降费措施。报告指出,2019年全年减税降费达到2.36万亿元,超过原定的近2万亿元规模,制造业和小微企业受益最多。

为应对新冠肺炎疫情对宏观经济和市场主体的冲击,报告提出将加大减税降费力度,强化阶段性政策与制度性安排相结合,助力市场主体纾困发展。今年将主要实施的减税降费政策包括:继续执行下调增值税税率和企业养老保险费率等制度;前期出台的免征中小微企业养老、失业和工伤保险单位缴费,减免小规模纳税人增值税,免征部分行业的增值税,以及减免民航发展基金、港口建设费的执行期限全部延长到2020年底。报告预计2020年全年将为企业新增减负超过2.5万亿元。

在本文中,我们总结了将在2020年下半年执行的减税降费政策,并与您分享我们的观察。

详细内容

看点 1: 延续增值税减税相关的制度性安排

自2016年"营改增"全面收官以来,深化增值 税改革、优化增值税税率结构是每年政府工作报 告中最大的财税亮点。近年来,中国出台了多项 深化增值税改革措施,包括:简并和下调增值税 税率、进一步贯通增值税抵扣链条、实施增量留 抵税额退税和部分存量留抵税额退税、逐步优化 货物及服务出口退税政策、进一步完善增值税优 惠政策等。深化增值税改革措施在今年继续执行, 对持续减轻企业税收负担产生叠加的累积效应, 将助力企业渡过难关,保持经济持续稳定发展。

需要注意的是,报告未提及调整增值税税率结构, 而是提出今年继续执行下调增值税税率制度,这 意味着除零税率外,在未来一段时间内可能将继 续实施13%、9%和6%三档税率。

2019年11月,财政部、税务总局公布了《中华人民共和国增值税法(征求意见稿)》(以下简称"《征求意见稿》"),《征求意见稿》也承袭了现行三档税率。结合近年来减税降费的大背景以及国务院提出的"按照三档并两档方向调整税率水平"的要求,未来在推进增值税立法过程中是否会同时调整和简并增值税税率,值得予以关注

看点 2:延长支持疫情防控增值税优惠政策

- 纳税人运输疫情防控重点保障物资取得的收入,免征增值税;
- 纳税人提供公共交通运输服务、生活 服务,以及为居民提供必需生活物资 快递收派服务取得的收入,免征增值 税;
- 疫情防控重点保障物资生产企业可以 按月申请全额退还增值税增量留抵税 额:
- 自 2020 年 3 月 1 日至 5 月 31 日, 对湖北省增值税小规模纳税人免征增 值税;除湖北省外,其他省份的增值税小规 模纳税人,减按 1% 征收率征收增值税;预 缴增值税项目同步降低预征率。

报告提出减免小规模纳税人增值税,免征公共交通运输、餐饮住宿、旅游娱乐、文化体育等服务增值税政策的执行期限全部延长到2020年底,为小规模纳税人和受疫情影响较大的生活服务业纳税人在复工复产中给予进一步支持。

看点 3:中小微企业的税费扶持政策

继续阶段性免征中小微企业的三项社会保险:为推动企业有序复工复产,支持稳定和扩大就业,人力资源社会保障部、财政部、税务总局在2020年2月联合发布《关于阶段性减免企业社会保险费的通知》(人社部发[2020]11号³),规定自2020年2月起,对不同地区、不同规模的企业执行阶段性减免企业基本养老保险、失业保险、工伤保险(以下简称"三项社会保险")的单位缴费,并明确中小微企业三项社会保险单位缴费部分的免证期限不超过5个月(即在2020年6月到期)。


为帮助中小微企业渡过难关,保障就业和 民生,报告提出将免征中小微企业三项保 险单位缴费的执行期限延长到 2020 年底, 有利于进一步减轻中小微企业的人力成本 负担。预计人社部、财政部、税务总局将 在6月底前按照报告的部署发文落实继续 阶段性免征中小微企业的三项社会保险的 政策。

延缓小微企业、个体工商户所得税缴纳:除继续阶段性免征中小微企业的三项社会保险外,报告还提到延缓小微企业、个体工商户的所得税缴纳到2021年,这对于缓解小微企业和个体工商户的现金流压力具有积极作用。关于小微企业延缓缴纳企业所得税、个体工商户延缓缴纳个人所得税的适用条件、

具体程序等问题,有待财政部、税务总局出台配套法规予以明确。

注意要点

减税降费是近年来中国宏观经济调控和积极财政政策的重要关键词。为应对国内外经济形势变化,中国陆续出台了一系列减税降费的措施,旨在支持实体经济发展,进一步为市场注入活力。2018年中国的减税降费总额达到2.36万亿元,2020年政府工作报告设定的减税降费的目标更是高达2.5万亿元,这将有利于减轻各类市场主体、尤其是中小微企业的负担,以保住就业民生,稳住经济基本

近期发布的《中共中央、国务院关于新时代加快完善社会主义市场经济体制的意见》⁴ 再次提及了中国税收制度改革下一步的方向:深化税收制度改革,完善直接税制度并逐步提高其比重。研究将部分品目消费税征收环节后移。建立和完善综合与分类相结合的个人所得税制度。稳妥推进房地产税立法。健全地方税体系,调整完善地方税税制,培育壮大地方税税源,稳步扩大地方税管理权

截至目前,中国现行的 18 个税种中,已制定法律的税种有 9 个(分别是车船税、环境保护税、烟叶税、船舶吨税、企业所得税,耕地占用税、车辆购置税、个人所得税、资源税),其余 9 个税种的立法工作仍处于进行时。其中契税法和城市维护建设税法草案已经全国人大常委会初次审议,并向社会公开征求意见;增值税法、消费税法草案征求意见稿已由财政部、税务总局向社会公开征求意见。据悉,印花税法草案送审稿正在由司法部进行立法审查。财政部在今年 2 月发布的 2020 年立法工作安排也提到将"力争在年内完成增值税法、消费税法、关税法的起草工作,并上报国务院"。

在当前全球疫情和经贸形势不确定性很大的情况下,报告提出积极的财政政策要更加积极有为,支持减税降费并加大减税降费的力度,释放了助力市场主体纾困、统筹推进疫情防控和经济社会发展的积极信号。我们将密切关注针对报告部署的减税降费政策的解读及相关具体政策的出台,并及时分享我们的解读和观察。

PREDICTING PREEMIES

Predicting preemies means recognizing the chances of a preterm baby. Usually, the standard period of gestation for a human being is 40 weeks. Babies that stay less than 37 weeks in the mother's womb are considered preterm babies. There are a lot of risks associated with preterm babies, primarily including their neural and physical growth, and the mortality rate of preterm babies is higher within the first five years of birth. Developed countries with better healthcare facilities often save the lives of preterm babies, but in the growing stages, these babies sometimes develop several disorders, including Down syndrome, which is genetic.

With these challenges in mind, bio technicians have worked on discovering a method of predicting preemies. In the past, genius minded Leonardo Da Vinci also endeavoured to discover possible reasons for a preterm baby, although he didn't write anything concrete about it. However, a biological engineer named Stephen Quake discovered a unique way to forecast preemies. It takes only a blood test to predict whether a baby will be born on time or preterm. Let's dive in to find out how this technology works and what it can bring to us.

HOW DOES THIS TECHNOLOGY WORK?

Before starting to work on predicting preemies, Quake was working on predicting the neural behaviour of humans through blood tests. He observed that every change happening in our body can be traced by studying patterns in the blood, because blood goes to every part of the body. For predicting potential disorders in a baby, doctors used to take blood from the womb to study DNA patterns, but since this could lead to pregnancy failure in some circumstances, nobody dares to take this risk until very necessary.

Quake has found a concrete solution to these problems by inventing a method of predicting preemies through an ordinary blood test on the mother. He was motivated to research this issue after his daughter was born prematurely, and by the time his daughter reached the junior year of high school, he had discovered this method. In his study, he found that women who give birth to premature babies show a different pattern in their blood than do normal pregnant women.

Quake chose to study the pattern of RNA compounds in the blood instead of DNA to obtain results. This variance in RNA pattern between a healthy gestation and premature gestation is the result of the interaction between mother and children. For predicting preemies, samples of the mother's blood test are taken more than one time periodically during gestation. In those samples, seven types of RNA molecules are tested. In studies, it has been proved that these seven RNA molecules in blood are found in higher numbers in the case of preterm labour.

In his clinical trial, which was done on 38 African-American women, he could precisely forecast delivery dates. A new startup has been formed by his team to facilitate this testing worldwide to save millions of lives.

PREDICTING PREEMIES TO HEALTHIER BABIES

In preterm babies, several kinds of health disorders occur. The earliest recorded preterm baby who survived was 21weeks. Now that baby has reached his twenties and is heading towards a healthy life. But many preterm babies are not as lucky as he was. A lot of preterm babies are born with disabilities, like hearing or seeing impairment. Many of the children who are born preterm suffer from lifelong lung disease due to improper development in the womb. Babies who come out early may also suffer neurological injuries due to soft body parts.

If we can predict preemies, then we can be prepared for these challenges. Doctors can give appropriate medicine so that preterm delivery doesn't affect a baby's life. Also, after the initial detection of preterm babies, precautionary measures can be taken to avoid any miscarriage.

Scientists have also invented an artificial womb for preterm babies. This artificial womb can be used for babies being born too early, even before 30 weeks.

Preterm babies are a problem around the globe; predicting them at the right time can save millions of lives, and save millions of children from being physically or mentally challenged. This technology will be a revolution in the field of medicine.

"全球十大突破性技术" 之早产预测

早产是指妊娠不满 37 周的分娩。积极开展早产的预测并及时提供预防性干预措施,对降低围产儿病死率及发病率有着重要意义。斯坦福大学的生物工程师Stephen Quake 已经找到了一种方法来解决医学界最棘手的问题之一:大约十分之一的婴儿过早出生。

运作原理

自由漂浮的 DNA 和 RNA 携带者以前需要侵入性细胞抓取细胞的信息,例如对肿瘤进行活组织检查或刺破孕妇的腹部进行羊膜穿刺术。不一样的是现在更容易检测和分析血液中无细胞遗传物质。

在过去几年中,研究人员开始通过从血液中检测肿瘤细胞的 DNA,以及通过血液检测对孕妇进行唐氏综合症等疾病的产前筛查。这些检测依赖于寻找 DNA 中的基因突变。另一方面,RNA 是调节基因表达的分子物质,能够决定从基因中产生多少蛋白质。

通过对母亲血液中的自由漂浮的 RNA 进行测序, Quake 筛选出与早产有关的七种基因表达的波动。这让他可以识别可能过早分娩的女性。一旦被警告, 医生可以采取措施避免早产,并给予孩子更好的生存机会。

预测早产儿的健康状况

早产是导致新生儿死亡以及5岁以下儿童死亡最常见的原因,而存活下来的早产儿与足月儿相比,短期和长期并发症如呼吸着迫综合征,支气管肺发育不良,坏死性小肠结肠炎,癫痫,脑瘫等的发生率明显增加。

早产婴儿是全球性的问题。在适当的时间 进行预测可以挽救数百万的生命,这项技术将是医学领域的一场革命。

The benefit of this will be that the reader will stay on your page longer and even read the whole blog.

YOU NEED TO LEARN TO FIND A NEEDLE IN A HAYSTACK

Before becoming a master at content marketing, you need to be a master at researching information on the web. There is no doubt that the internet is the most potent and essential tool today for your marketing efforts. Learn to do research for things that others cannot find. And to do that, you need to think differently from others. Even though the information you are

about to share is similar to what others are saying, it's the way you present it that matters. And this brings us to our next point, creativity.

BE CREATIVE

CHINESE TECH GIANTS ANNOUNCE NEW DISTRIBUTED IDENTITY ALLIANCE

A new alliance of Chinese tech giants has been formed with a specific focus on distributed identity, in the latest collaboration to hit the blockchain scene.

In the latest example of major companies pulling together to drive innovation through blockchain, the Distributed Identity Alliance (DID Alliance) was founded by 17 Chinese firms across sectors. Among the big names to sign up to the alliance so far are Baidu, Tencent Cloud, WeBank, JD.com and UnionPay Electronic Payment Research Institute.

The group was set up to investigate and research distributed ID technology, with a view to developing commercial applications of the technology in various settings.



The alliance will ultimately work to create open source technologies, adopting international standards to help local businesses bridge the gap to international digital ID consortia.

MEDICAL ROBOTICS IN CHINA: THE RISE OF TECHNOLOGY

In 2006, China highlighted the importance of robotics in its 15-year plan for science and technology. In 2011, the central government fleshed out these ambitions in its 12th five-year plan, specifying that robots should be used to support society in a wide range of roles, from helping emergency services during natural disasters and firefighting, to performing complex surgery and aiding in medical rehabilitation.

Guang-Zhong Yang, head of the Institute of Medical Robotics at Shanghai Jiao Tong University, says that China's robotics research output has been growing steadily for two decades, driven by three major factors: "The clinical utilization of robotics; increased funding levels driven by national planning needs; and advances in engineering in areas such as precision mechatronics,



medical imaging, artificial intelligence and new materials for making robots."

In 2019, the number of da Vinci systems installed in Chinese hospitals that year leapt to 59, up from only 8 installations in 2018. This surge followed a 2018 government push to encourage research on robotics technology and its clinical application, according to Jian-Kun Hu, director of the Department of Gastrointestinal Surgery at West China Hospital in Chengdu. The central government's plan included an intention to purchase 154 new surgical robot systems by the end of 2020, and a breakdown of how the systems would be allocated nationwide.

AI IS KEY TO CHINA INFRASTRUCTURE PLAN, AS IS AI TALENT

CHINESE DNA SEQUENCING COMPANY RAISES A RECORD \$1

China's latest set of technology goals for the next decade have been assimilated into an initiative launched this spring under the rubric, "new infrastructure." Collectively, the aspirational blueprint includes 5G wireless and the Internet of Things, big data and Al as well as converged infrastructure aimed at a menu of smart applications ranging from energy and transportation to spurring R&D and product development.

Chinese technology giants such as Alibaba (NYSE: BABA) and Tencent (OTCMKTS: TCEHY) quickly jumped on the new infrastructure bandwagon. This week, Chinese AI and search conglomerate Baidu (NASDAQ: BIDU) joined the growing list by announcing plans to train five million AI developers by 2025 while deploying an equal number of AI cloud servers across its 10 data centres by 2030.



Beijing's infrastructure initiative "will be the new driver for China's economic development in the coming decades, and emerging technologies such as Al, cloud computing, 5G, IoT and blockchain are its key technological pillars," said Baidu CTO, Haifeng Wang.

"As an AI platform company, Baidu will use its many achievements and years of practical experience in AI technology to help speed up the development of new infrastructure and facilitate implementation of AI so that all industries can leverage it for unprecedented new momentum."

CHINA'S GPS COMPETITOR IS NOW FULLY LAUNCHED

For decades, the United States has had a monopoly on positioning, navigation and timing technology with its Global Positioning System (GPS), a constellation of satellites operated by the military that today provides the backbone for location on billions of devices worldwide

Few countries, though, have made the investment that China has made into its Beidou (北学) GPS alternative. Over 20 years, the country has spent billions of dollars and launched nearly three dozen satellites to create a completely separate system for positioning. According to Chinese state media, nearly 70% of all Chinese handsets are capable of processing signals from Beidou satellites.

Now, the final puzzle piece is in



place, as the last satellite in the Beidou constellation was launched into orbit, according to the People's Daily.

While the completion of the current plan for Beidou offers Beijing new flexibility and resiliency for this critical technology, ultimately, positioning technologies are mostly not adversarial—additional satellites can offer more redundancy to all users, and many of these technologies have the potential to coordinate with each other, offering more flexibility to handset manufacturers.

As government affairs professionals, especially those who are working on the cooperation between multinational companies and the Chinese government, we know that the most important and difficult part of our daily work is the communication between Chinese and Western cultures. On the one hand, when we are faced with Chinese government officials, we introduce Western historical experience and are not good at communicating in localized languages; on the other hand, we can have a deep understanding of China's politics, economy, society, and industry. Communication is both an art and a theory.


